I WISH proposes to use Instagram and Facebook and other social media websites as they arise, to provide information updates on the 2019 events. These websites will be used to share varied information relating to the I WISH events including interviews with students, photographs, links to film/videos, testimonials etc.

PHOTOGRAPHY CONSENT

I WISH will take photographs and film footage of participating students at each of the events taking place. These photographs and short film excerpts will be used on the I WISH website, social media websites, in local or national newspapers and televised news programmes. The photographs and films will be used in promotions for I WISH and I WISH partnership events, where we deem it reasonably necessary.

We require the permission of each student and where that student is under the age of eighteen, we also require the permission of his/her parent/guardian to use the personal data of the students in this manner.

All personal data that we collect, including photographs and film footage, shall be uploaded to the I WISH social media pages. As a result of this, it is possible that social media websites shall take the images and film footage that we upload and use them for their own purposes which is beyond the control of I WISH.

If, at any stage, you wish to have your personal data and image removed from I WISH social media websites, please put your request in writing to sharon.lombard@iwish.ie and we shall remove the personal data on receipt of written request.

Images and film footage of all students shall be retained for two years following their participation at the events.

We will engage third parties, including photographers and event companies to process student's personal data on our behalf. We will only do so where appropriate contractual arrangements are in place which shall protect the personal data.
